## ANCESTOR CORNER

Dr. Josiah Fuller was born July 17, 1739 in Ipswich, Essex Co., MA, the son of Jacob Fuller and Anna Harris. He married Mary Smith and they were living in Norwich, CT in 1757 when their daughter Mary was born. In 1761 the family moved to Bennington, VT. Josiah was a private in the 1<sup>st</sup> Company of Militia organized at Bennington on 24 October 1764.

Dr. Fuller happened to be a New Hampshire grantee and resided in the Walloomsack Patent. In January of 1771 it was his farm as well as that of James Breckenridge that Sheriff Ten Eyck marched to with the Albany Militia in an attempt to serve the Crown's Writ of Ejectment. The sheriff met armed resistance from a number of men who had shut themselves up in these two farm houses and threatened the Sheriff's life if he proceeded. This was reportedly the first armed resistance by the Green Mountain Boys against the Crown.

Josiah's signature appears on the Bennington Declaration for Freedom which, though undated, is believed to have been written in early 1775.

Josiah Fuller, Surgeon's Mate, was paid from 3 May to 20 July 1775 by the state of Connecticut for his services on the Ticonderoga Expedition. He was also paid for services at Manchester and Castleton. Dr. Fuller was a Surgeon's Mate at the Battle of Bennington, serving under Capt. Herrick. He was also called to service in October of 1780 and on 21 May 1781 for the defense of the state of Vermont.

Dr. Fuller died intestate sometime before 2 December 1805 in Bennington, VT. His grave has not been found.

# **VICTORY WOODS TRAIL OPENS**

Victory Woods is a new National Park site, located just south of the Saratoga Monument in the Village of Victory. The park features an accessible boardwalk trail. The 22-acre parcel was donated in the 1970's by Victory Mills Packaging, but further development was delayed until 2005 by lack of funds. SNHP Superintendent Joe Finan says: "We are very pleased to open this site as it allows us to more fully tell the important events after the Battles of Saratoga, including the American siege of British

forces that retreated here and their eventual surrender – one of the most pivotal events in the American Revolution."

The trail is now open from dawn to dusk, and occasional ranger-guided walks will be scheduled throughout the summer. Soon, the trail will link with the Champlain Canal Trail and other developing trails in the area.

# C.A.R. SOCIETIES SHINE

This fund-raising project will support the New York State Battle Flags Preservation Project at the NYS Military Heritage Institute in Saratoga Springs as well as the purchase of the aforementioned monument in the Saratoga National Cemetery.
