ANCESTOR CORNER

My ancestor, Joseph Calkins, was born In Hebron, Hartford, CT on June 2, 1737, the son of Stephen Calkins and Mary Curtis. His father, Stephen, was too old for front line duty in the Revolution but he served in the Sharon, CT militia and took part in alarms and training. He had nine sons, all of whom supposedly took part in the war to some degree.

Joseph served under Captain Downs in Col. Burrell's Connecticut regiment. This unit was under the command of General Arnold during the fighting around Montreal. In May of 1776 several skirmishes occurred about 30 miles west of Montreal at a placed called the Cedars. The garrison surrendered to a combined force of British and Indians, mostly Iroquois, led by Captain George Foster on May 19. Units sent to their aid were also captured the next day. Captain Foster and General Arnold negotiated a trade of equal numbers of prisoners and all the Americans were freed. Congress rejected the settlement and no British were ever freed.

Joseph Calkins survived the war, returning to his wife, Deborah Crippen, and family. They moved to Tinmouth, Rutland, VT where Joseph died on October 3, 1806. He is buried in an unknown location in that town.

ANCESTOR CORNER

The following is a description of the Revolutionary War service of John Marsh b. 25 Nov 1758. It is an abbreviated abstract of his handwritten deposition to the Litchfield Co., CT Probate Court in application for a federal pension. Question marks indicate text which is not clearly readable.

That in the latter part of June 1776 he enlisted into the service of the United States as a Private soldier for the six months in Capt. Stephen Goodwin's company & Coll. Fisher Gay's Regt. of the Connecticut line, as he supposes; was marched to New York & afterward on to Long Island, where he remained until the 15th of

September, when they were driven off the island by the British & retreated to New York. He recollects seeing the British flag waving in the City of New York the same day. That he was one of about 3000 men as should think, under the command of Gen. Wadsworth who were placed in a trench on the East River a little above the City while Gen. Washington drew off the main body of the Army to Kingsbridge, & on the next day (Sunday PM) they left the trenches under the fire of the enemy & retreated to the main body. He recollects that when they left the trenches a soldier was shot through the knee or leg and fell. That Gen. Wadsworth told some of the men to put the wounded soldier on his horse behind him, which they did, & the horse leaped over a stone wall with them and were carried safely off. That in leaping the stone wall he heard the balls of the enemy strike against it. That he threw his pack & gun over the wall and pitched over on to them & then raised his gun & ran with all his might, but left his pack behind. That though they were exposed to the incessant fire of the enemy, not many were killed. He knows of no person living whose testimony he can obtain to prove this service. That he served out the term of his enlistment and was discharged the 25th day of December. That in the spring of 1780 he enlisted for nine months in the 1st Company, commanded by Capt. (? Miles or Miller), in Coll. (?Herman) Swift's Regt. of the Connecticut line. That he served out the term and was discharged in December at he highlands. Was with the main body of the Army along the North River & in New Jersey during the whole term. Of this service he has the testimony of Elijah Gaylord & Roswell Marsh. That in September 1781 he again entered the service as a substitute or for a (?class) who were to furnish a man, he was hired by Elihu Barber of Torrington, he thinks company was commanded by Capt. Buckley, one (???) was orderly (???) the Regt. commanded by Coll. Samuel B. Webb & called the 9th Connecticut Regt. & served three months. Joined the army at Peekskill on the North River. Gen. Washington was there & remained with them until he left with a part of the army for York Town. From Peekskill removed to (???) Town New Jersey where he was when the news arrived of the capture of Cornwallis.

Congressman Bill Owens of the 21st Congressional District welcomed the new citizens and their families. Kathy Marchione, NY state Senator from the 43rd Senate District addressed the new citizens.

This year's master of ceremonies and keynote speaker was Dr. Ray Raymond MBE, DSM, FRSA, Professor of Government and History, SUNY; Adjunct Professor of Comparative Politics, USMA. Dr. Raymond was both knowledgeable and entertaining. Danielle McMullen led the group in singing the National Anthem.

Saratoga Battle is a co-sponsor of both the Schuyler and Bemis Heights Societies, N.S.C.A.R. and both societies have been busy.

Susan Szewczyk, Senior Vice President of Bemis Heights reports that the society was recently recognized with a number of national awards:

Honorable Mention for National Merit Award entry; 1st Place, Best Prayer, National Chaplain's Contest; 3rd Place, Local Society with the Best Program on the Importance of Artwork Housed by the Federal Government.

The N.S.C.A.R. National Project & Theme is "The Pursuit of Happiness." The plan is to raise \$50,000. The mission of this group is to provide military veterans with the resources, support and advocacy needed to succeed in higher education and following graduation.

This money was raised as part of a project to raise funds for a bronze bas relief monument at the site. The unveiling of this monument during the ceremony was an exciting culmination to the year-long project. Congressman Paul Tonko was on hand for the ceremonies.
